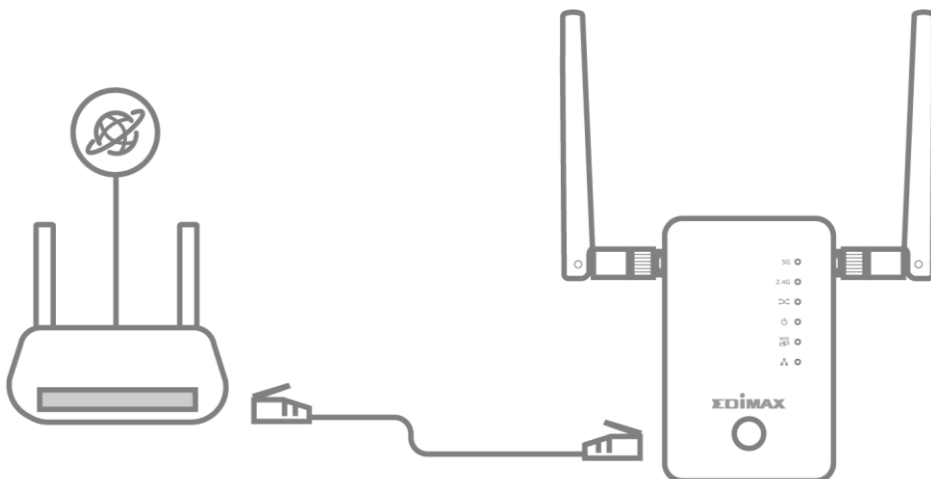

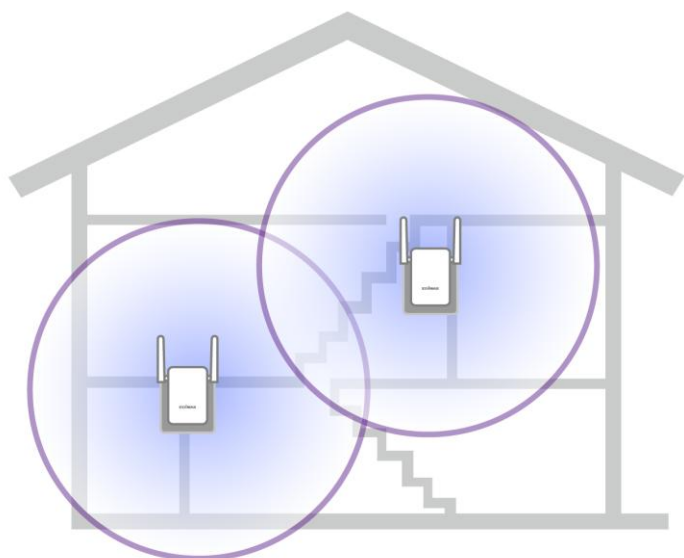

2. Druk op de WPS-knop op de master RE11S en houd deze 3 seconden ingedrukt.
3. **Binnen 2 minuten**, druk op de WPS-knop van de tweede RE11S en houd deze ingedrukt. Zowel de 5G als de 2.4G LED moeten eerst knipperen.

Veelgestelde vragen (FAQ)

1. Ik kan de loginpagina niet zien <http://edimaxext.setup> in the browser, wat kan ik doen?

A: Om de situatie te corrigeren, *probeer een van de volgende methoden:*

- Controleer of uw computer verbonden is met het RE11S netwerk.
- Controleer of uw computer geconfigureerd is op “Automatisch een IP-adres verkrijgen” en “DNS serveradres automatisch verkrijgen”.

2. Ik heb geen toegang meer tot de RE11S. Ik denk dat ik een verkeerde wachtwoordzin of beveiligingssleutel heb gebruikt op de RE11S gedurende het set-up proces (mijn router beveiliging is WEP). Wat kan ik doen?

A: Omdat de RE11S geen WEP wachtwoordzin kan controleren, dan kan uw apparaat niet het correcte IP-adres verkrijgen van de RE11S in het geval van een verkeerde wachtwoordzin. *Herstel de fabrieksinstellingen van de RE11S en doorloop de set-up opnieuw.*

A: *Houd de WPS-knop gedurende 10 seconden totdat de voedings-LED langzaam begint te knipperen.*

4. Wat moet ik doen als ik mijn login wachtwoord vergeten ben?

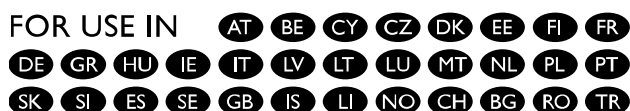


